Dear Colleagues, Dear Friends,

CiCea, our European Association on Children's Identity and Citizenship, was born in Riga in May 2006, as the need to establish a new international association in the field of identity and citizenship clearly appeared. Two years later, after our conference in Montpellier (2007) and in Istanbul (2008), this need is confirmed even if CiCe 4 has been accepted as an Academic Network for three more years! Nevertheless, CiCea needs to remain independent, to increase the number of both individual and institutional members and to develop specific activities.

In this context, it is time for the first issue of CiCea's newsletter: here it is! We will try to publish it at least four times a year. In our newsletter, we wish to allow members to comment on different research projects they have read about, to advertise research events, conferences, special issues, and so on. In each issue, there will be some fixed columns, such as one under the direct responsibility of Marta Fülöp, our Research and Publications officer. Do not hesitate to contact her directly (fmarta@mtapi.hu) for any short paper of interesting information you might have.

Concerning research, as we did last year, once more we are starting a competition to offer a small support grant for collaborative research project related to identity and citizenship between members of Association. This implies that the Association's second Research Grant **Competition** is reserved to CiCea members, from different countries, - colleagues with whom you wish to present a research project can easily become a CiCea member-. - Although there are no Executive elections this year, there will be an election for a new President-elect in 2009/10, and for new Executive members the following year start thinking about serving your Association now!

### Research Grant Fund competition by Marta Fülöp, Research and publications officer

The Association is inviting applications from groups of members for research support. The Executive hope to provide a minimum of one award of 1,500 Euros in May 2009. Applications should be made on the form below, and e-mailed to the Association office (cicea@londonmet.ac.uk) by 31st March 2009.

#### **Application Guidelines**

- The application must be made by a group of at least THREE Association members, from different institutions. International collaboration is strongly prefered.
- Please indicate the **title** of the research proposal.
- Please provide a one page long CV of each applicant and a list of publications that are relevant in relation to the proposed research project.
- Please describe the aim of the research and its relevance in terms of citizenship (250 words).
- Please give a short theoretical background: what has been done in the given field and how the proposed research can contribute with new insight to the already existing knowledge (500 words).
- Please describe the **planned research**: sample (who will be researched if applicable), what methodology will be used, how the results will be analyzed and provide an indicative **timetable** (750 words).
- Please describe the planned outcomes of the research (publications, conferences,

- educational use etc.) (250 words).
- Please provide an informative and detailed **description of the budget**. The financial planning should be realistic.
- o In case the grant is to be used to supplement other awards or grants, the research proposal must then clearly specify what the present proposal adds to the overall project.
- The Association will require a **final report** at the end of the project, describing how the goal of the project was met, the research itself and its results, and planned dissemination of the results (3000 words). The final report should also contain an appendix on the **descripton of the expenditure**.
- The project proposed should be completed within 18 months. It must start by October 1st 2009 (and therefore **should end by March 2010**).
- The support of the Association must be acknowledged in all reports, articles, etc., resulting from the project.
