Big changes and developments are being planned for our Journal! Plans are well advanced to have it professionally published, and on a more frequent basis.

We have been publishing the Association's Journal – Citizenship Teaching and Learning – in collaboration with the citizED group. This is a UK-based group of citizenship educators, with an international outreach, and the editor, Professor Ian Davies of the University of York, is a very active member of both groups.

Over the last couple of months there have been close negotiations with an academic publishing house to take over the printing and sales of the journal – something that will be done in formal association with CiCea and citizED.

This will probably start in the summer of 2010, and by 2011 we hope to be

regularly producing three issues a year. All Association members will continue to get their copies directly from CiCea – and for our Institutional members, this will be a way of securing copies for your University Library at a substantial saving! The negotiations are not quite complete yet – when we have final confirmation, we will report it to you in the Newsletter.

## Unesco Chair On Gender Equality And Empowerment -University Of Cyprus

A UNESCO Chair on Gender Equality and Empowerment has recently been established at the University of Cyprus, with Dr Mary Koutselini, Department of Education as Chairholder. The network of partners includes institutions, academicians, GOs and NGO's in Europe, the Balkans and Middle East. It should be noted that members of CICE and CICEA participate in the Chair's partnership.

The Chair's Partnership is carefully designed to contribute to North -South and South-South collaboration, regardless of geographical locations, for the promotion of a creative dialogue mainstream anticipation problems and negative attitudes in the socio-economic, educational, political sphere. From this point of view, the partnership seeks to diagnose the real needs of each region and to act as a creative think tank that supports the development of local poles for the elimination of the theory praxis divide in gender equality and empowerment. # New researches for citizenship

Evdoxia Traianou: PhD Candidate. Title of thesis: "Citizenship through history learning: The aspects of curriculum, textbooks and students' point of view in Greek educational system"

whether .We examine the history curriculum of the Greek educational system, the state approved history textbooks, teacher guidelines and other supplementary materials promote citizenship and political socialization. More specific we examine student's levels of knowledge about political concepts such as utilized in the curriculum, basic civic skills like greater confidence to understand political concepts and better interpretation of political issues and civic engagement such as volunteering, community service and political engagement. In order to achieve these goals we examine curriulum and textbook by discourse analysis and distribute questionnaires to students. The research is conducted at third grade of lower secondary education (14 year old students).

Christos Zagkos, "The parliamentary elections in the prefecture of Florina (1926-2009). The political culture and the national ideology as they are presented in the local press of the region"

Using the content analysis method in combination with the semiotic analysis of the local newspapers and the method of leximetry we are trying to reveal the "hidden" messages of the pre-election newspaper articles, to investigate the relations between political power and press, to analyze the methods of the political propaganda used by the local press and finally to investigate the features of the local political culture.

Maria Keramyda, TV advertisements and children: Exploring the ways children understand TV advertisements and the outcomes of media education.

After examining scientific results regarding the amount of time children spend watching television and the way they understand its messages, we came up with two main goals: a) to study the way children comprehend and TV understand advertisements, especially as far as gender and identity is concerned, and b) to study the potential of improving the way children comprehend and understand this TV genre, after having attended several classes on how to read an advertisement, c) Are there any patterns referring to the western culture and the western way of life.

# The biggest number of members from one country!

Short interview with **Prof. Magda Danciu**, University of Oradea, Romania Interviewer: Dr. Márta Fülöp

MF: CiCea has the biggest number of members from Romania. You have been a very active and long-term member of CiCe participating in different working groups. Now you are also a member of CiCea. How would you explain the keen interest towards the work in CiCea in Romania?

MD: After joining the EU people's interest for the issue of citizenship has grown in Romania and there has been the need for teaching young people (pupils, students) about how to cope with this moment in the present history of their/our country.

**MF:** What can CiCea offer to those who are interested in these issues?

MD: The CiCe project has worked on providing theoretical background and guidelines, plus a good practical demonstration of how these theories can come to life and can be applied in different countries, with focus on local/regional particularities The initial members of the thematic network, prof. Vasile Marcu, prof. Letitia Filimon and myself, worked on presenting, explaining, lecturing to our students and colleagues on the academic findings coming from the other universities of Europe, inculded in the publication emerging from the project working groups and researchers.

**MF:** You and your colleagues organized the first Working Group seminar for CiCe 4 in your university last October. Did this have any effect ont he number of members joining the Association?

MD: The nearing, and then the real happening of the CiCe event in our university made our colleagues more concerned with the issues developed within the project. This was an important event to come and members of approached NGOs decided to join the Association to share the information, newsletters, journals with their peers.

**MF:** Do you consider it professionally valuable for you and your colleagues to be member of CiCea? MD: The CiCeA members, both institutions and individuals, consider the membership of such an international association a relevant element in their institutional or personal CV.

**MF:** We are very pleased to have you and the Romanian colleagues as members and continue to have a fruitful cooperation with the Romanian members.

#### Annual Research Student Conferences

This year CiCe organizes again the annual "New Researchers for the New Europe" conference and workshop for research students. This is a one and a half day long pre-conference of the main CiCe conference.

This will be the fourth occasion to get research students together from several different countries of Europe to present and discuss their ongoing research work with fellow students and an international and interdisciplinary group of professors. So far these conferences have been very much appreciated by students, it is a good way to get and give professionally high level feedback on their work in a friendly and safe atmosphere.

The conference is also a good occasion to get to know other young researchers int he field and establish long-term collegial relationships. This vear the conference will be held in Malmö and we have 16 students to present their work from universities in Finland, France, Germany, Hungary, Iceland, Portugal, Sweden, and the UK. The members of the team professors are Luigi Caiani professor of history from the University of Rome La Sapienza, professor Penelope Harnett education from the University of West England, Roger Johansson professor of history, University of Malmö. The group is chaired by Márta Fülöp, professor of social psychology, Eötvös Loránd University, Budapest.
