## CiCea's News: York AGA approved activities



### Our activities

Our Annual General Assembly meeting held on May 25<sup>th</sup> was highlighted by several announcements including: a) confirmation/election results: Chris Gifford's confirmation as our Treasurer and Henry Maitles as our incoming President-elect; b) naming of the Annual CiCea Best Publication Award which went to: Andrew Mycock from the University of Huddersfield for his publication with his co-author Jonathan Tonge entitled "A Big Idea for the Big Society? The Advent of National Citizen Service", published in *The Political Quarterly*, 82(1): 56-66; c) naming of the Annual CiCea Outstanding Achievement Award which went to Professor Emeritus Panagiota "Titi" Papoulia-Tzelepi in recognition of her tireless efforts on behalf of not only the Association but her unstinting dedication to supporting the precepts of children's rights, identity and citizenship; and d) a formal recognition and expression of thanks to our outgoing Past President Christine Roland-Lévy for her many years of dedication to the Association. Besides these announcements, the Annual Executive Report was presented, proposed and seconded as was the Treasurer's Report.

The "Executive Proposed and Approved Activities for 2012-2013": To define different activities in order to increase the fundamental & applied research visibility of the Association:

- To broaden and publicize the activities of our Research Centres,
- To continue providing an annual award for one or two outstanding published paper(s).
- To study the feasibility of introducing an annual

award for one or two student outstanding published paper(s).

- To offer a Research Grant Award the amount of which will be dependent on CiCea finances.
- To continue providing an award for outstanding achievement.
- To complete the survey of the membership on the types of specific research activities they conduct and/or are involved in related to the Association's missions.
- To further promote and publicize the establishment of regional and/or national CiCea affiliates and to support the regional Citizenship Education conferences & seminars.
- To establish a peer-reviewed online publication under the aegis of CiCea and located on the Association webpage, to which members can submit papers to be published.

### York Conference

## Creating Communities: Local, National and Global

CiCea held a successful annual conference with the theme of Creating Communities: Local, National and Global, at the University Of York, UK, from 24th-26th May. The Conference Programme and Abstract book can be viewed on the website <http://cice.londonmet.ac.uk>

The numbers below give a flavour of the event.

**3** is the number of days of conference activity involving paper presentations, poster sessions, keynote lectures, workshops and more.

**34** is the number of countries represented by presenters (the number is greater for delegates!) coming from Europe, Asia, North America and the Middle East.

**200** The conference attracted nearly 200 delegates

**7** is the number of symposia reflecting research, policy and practice in relation to a range of issues and interests including social justice; active citizenship; democratic conflict, the child in media; affects of domestic violence; and creating citizenship communities.

**5** workshops took place encouraging interaction in relation to a number of topics including those exploring citizenship, identities, community development and pedagogy in times of crisis.

**90** is the number of papers presented. They covered diverse subjects within the conference theme; perspectives from a range of academic disciplines; and, a range of contexts at local, national, regional and global scale.

**25** degrees Celsius was the temperature in sunny York.

**CiCea double for the University of Huddersfield, UK**

Academics from the University of Huddersfield were delighted to have pulled off a rare 'double' at the annual conference in York.

Camilo Tamayo Gomez, a doctoral student within the School of Human and Health Science, won one of the prizes for best postgraduate paper for his presentation, 'The instrumentalisation of the

communicative citizenship field in the context of armed conflict: the case of the Association of Organised Women of Eastern Antioquia in Colombia'.

Reader in Politics Dr. Andy Mycock, was awarded the prize for the best research paper for his article 'A Big Idea for the Big Society? –The Advent of National Citizen Service' which was published in the internationally-influential journal, *Political Quarterly*, and co-authored with Professor Jon Tonge from the University of Liverpool.

The University of Huddersfield has been a member of the European Thematic Network since 2006 and is one of main contributors in the UK. Dr. Chris Gifford, the University's Head of Department of Behavioural and Social Scienc-

es, was elected to the position of Treasurer on the Executive of the CiCea network and Dr. Pete Woodcock, the University's Head of Criminology, Politics and Sociology, was elected as the UK national coordinator last year.

"CiCea provides a fantastic opportunity for UK scholars to share their high quality research with like-minded scholars from across Europe and, indeed, the wider world," said Dr. Woodcock. "I am delighted that researchers from Huddersfield took part in the recent conference and particularly pleased that Andy and Camilo won prizes. This illustrates the strength of research in this field from the UK and Huddersfield in particular."

## Farewell to Christine Roland-Lévy, CiCea's former past-president

### A brief biographical note

Professor in social psychology, Christine Roland-Lévy obtained her PhD, in 1981, for which she had a Fulbright scholarship, from the University Paris Descartes-Sorbonne, where she had a position for more than 20 years. She then moved to Rheims where she still is. She was the head of the Research Laboratory of Applied Psychology, LPA EA 4298 at the University of Reims Champagne-Ardenne (2008-2012). She is now the head of a Masters Degree, and in charge of the Doctoral Seminar for PhD students in psychology. Her main focus of research is economic socialization, social representations and behaviour. She is the author and/or co-author of more than 40 articles in international academic journal, has published 10 scientific books, and has participated in

more than 100 international conferences.

Since 2010, she is the President of the *French Consortium of Psychology Associations*. Besides that, since 2007, she is the President of a major French trade union for university staff and researchers.

Concerning CiCea and of CiCe, she has been a member of CiCe, since the first conference in London in 1992. She became a member of the Executive a few years later, and was in charge of the construction of the online *European Masters Degree on Citizenship and Identity*, which she was the head of for 5 years. In parallel, she actively participated in the development of the project of working with and for PhD students, by introducing, some years ago, the Student conference, and by elaborating the project for CiCe5 of

developing a European Doctoral School on the topic of citizenship and identity. She is Past-President until September 30<sup>th</sup> 2012, after 6 years of being President-Elect, President before becoming Past-President. She actively participated in the creation of our association CiCea.

Her projects are now focussed on the organization of two major congresses, which will take place in 2014. The first one is with the *International Association of Applied Psychology*, IAAP, which will be 8-13 July in Paris, with 7000-10000 participants expected; and the second one, from the 15<sup>th</sup> to the 19<sup>th</sup> of July, in Rheims, is for the *International Association of Cross-Cultural Psychology*, IACCP.

She will remain with CiCe and CiCea for many years!

### The cooperative competitive citizen

#### Overview

Citizens operate in social conditions of both cooperation and competition and society needs both individual initiative and collaborative effort. There has been a lot of arguments for the superiority of cooperation in civic behaviour however there has been relatively few research how being cooperative can be maintained when the context is competitively structured and intensive competition takes place i.e. in economic and political life. To

be able to keep competition and cooperation/solidarity together is a key task in the field of politics, economics and education. Destructive ways of competing should be avoided and constructive and cooperative ways promoted.

The proposed special issue will investigate what it requires to be a constructive/cooperative competitive citizen. Also it aims to devote special attention to the role of socialization and education. The call for papers will welcome articles that report recent research or theoretical ideas on these issues.

All manuscripts will be peer reviewed by two reviewers. Because of the limited number of manuscripts that the special "Cooperative Competitive Citizen" issue may include, those manuscripts not included will be forwarded to the journals regular editors for publication consideration in later issues.

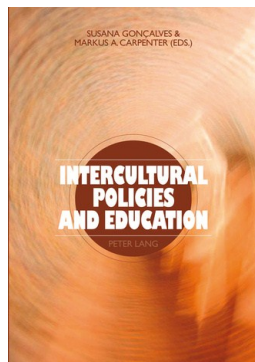

Intercultural Policies and Education is concerned with educational challenges in multicultural societies. Educational policies, practices and strategies for fruitful coexistence in the multicultural school and classroom are explored and analysed through a collection of chapters designed and selected to provide readers with international, multidisciplinary and multidimensional perspectives on the topic.

The first section of the book is focused on intercultural policies, pedagogy and curriculum, addressing aspects of interest to school management, like teacher recruitment, the

internet, intercultural communication at school from a philosophical point of view. Further, the first part deals with the influence of phenomena such as globalization and includes an analysis of universalism and cosmopolitanism.

The second part entails more specific approaches to education, the school and coexistence, by addressing a number of cases from European schools and results from educational projects, thus complementing the theoretical and conceptual framework presented in the first section.

This collection of essays and case studies presents a

reasonably comprehensive picture of the situation in Europe and contributes to a better understanding of pluralism in society and especially in school.

Among other authors, the book includes chapters from the following CiCe members: Alistair Ross, Márta Fülöp, Maria Olson and Susana Gonçalves.

It will most probably be effective from the 1st of January 2014, that is if the Council (27 Member States) and the European Parliament can agree on the new proposal, bearing in mind all the recommendations of all the parties interested in EU education and EU money!

The proposal integrates the seven existing programmes on education and training: Lifelong Learning Programme, Youth in Action, Erasmus Mundus, Tempus, Alfa, Edulink and the programme for cooperation with industrialised countries.

This "seven in one" programme will increase efficiency, make it easier to apply for grants (simpler rules and procedures), as well as reduce duplication and fragmentation.... let's hope the European Commissions' vision materialises in reality.

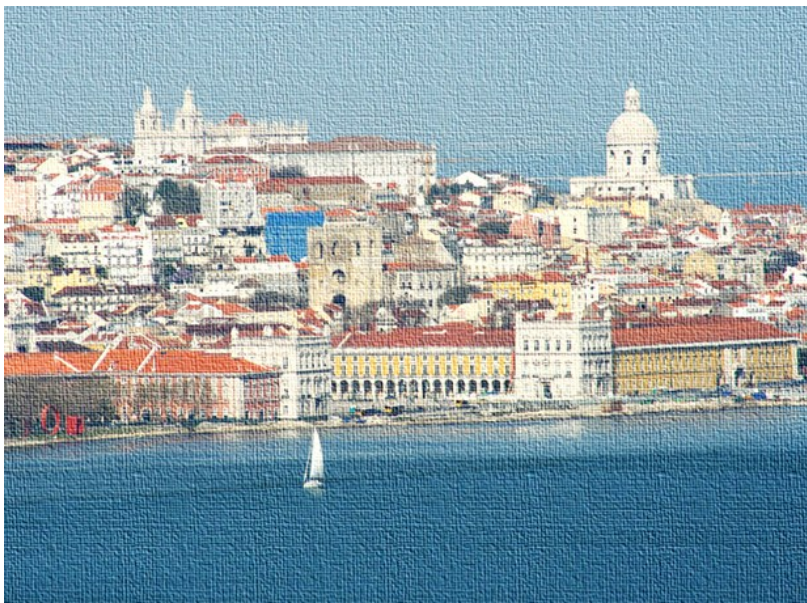
