## Do not Forget to vote for the new President elect!

Dear CiCea members,

As this issue is coming out, spring begins.

Spring will be for CiCea time for our renewal. As you recall, elections are about to start. Nominations close on the 26<sup>th</sup> March; and you will receive your election papers on the 12<sup>th</sup> of April, as voting papers and candidates' statements will be sent electronically to all CiCea Members (Institutional Contacts and Individual Members). Only those who are paid-up members by March 26<sup>th</sup> 2010 will be eligible to vote. Members must vote electronically on the papers provided. Voting will close on May 10<sup>th</sup> 2010.

Each vote is important, and as I am writing this, we are holding regional elections in France, with an incredible high number of no votes: around 55% of the French voters did not vote for this election, which concerns everyone... Politicians worry and try to understand why so many do not vote, and the global explanation leads to the lack of feeling as potential active citizens. Of course members of CiCea are active citizens, clearly involved in citizenship! Those who are individual members only have one vote. Each institution has ten votes.

Only those who are paid-up members by March 26<sup>th</sup> 2010 will be eligible to vote. Members must vote electronically on the papers provided.

Voting will close on May 10<sup>th</sup> 2010. The outcome of the election will be announced at the CiCe Association Annual General Assembly in Barcelona on May 22<sup>nd</sup> 2010.

# COPORE

Project approved by the European Commission includes Cicea members

COPORE (COmpetences for POverty REduction) is a consortium of health, social and educational networks that presented to the European Commission successfully an ERASMUS Accompanying Measures Project within the framework of the European Year 2010, combating poverty and social exclusion. It will be managed by ENOTHE, the European Thematic Network of Occupational Therapy in Higher Education.

The COPORE project aims to define competences and recommendations for health, education and social work students and practitioners on how to contribute to poverty reduction strategies. The project aims to bring together all major actors in the field, identify good practices, and develop a common language on social determinants of health and indicators of poverty. The project aims to select existing good practices in the field of interdisciplinary community care, and invites students to develop interdisciplinary projects on poverty reduction in collaboration with disadvantaged groups from local communities.

Working groups will prepare strategic papers on themes including community development and client participation, competences for monitoring social determinants of health, interdisciplinary approaches, preventive and outreaching approaches, and multidisciplinary education with regard to poverty reduction.

## The CiCea European Research Network Catalogue 2009 - 2010

As part of the Children's Identity and Citizenship European Association's services for members a network of European Research Centres has been created in September 2009.

Eight institutional members of the Association have agreed to make meeting and study places available to other members of the Association. This facility is for members of the Association who wish to meet or study in one of the locations. Members may use the centres, with the agreement of the host in each case, for

- a study base for an individual for a short period of time
- as a research base, to collect data in the locality and its environs
- as a meeting place for a research/study project.

The host institution will try to accommodate requests for use of the facilities, assist in suggesting convenient accommodation, and endeavour to help you identify schools or colleges that may be useful to you in any research. Members receive a catalogue that details the research centres and facilities that are available.

## Media Education: international conference 5<sup>th</sup>-6<sup>th</sup> November, 2010 Castelo Branco, Portugal, www.literaciamedia.com

The outcomes of the Project 'Media Education in Castelo Branco region' (Portugal), a funded research project, will be presented at this conference, to be held in ESECB (College of Education of the Polytechnic Institute of Castelo Branco).

Invited Key note speakers are internationally well-known researchers: Evelyne Bevort (Clemi), Pier Cesare Rivoltella (Universidade Católica de Milão) and Aguaded-Gomez (Grupo Comunicar – Huelva).

The project "Educação para os Média na Região de Castelo Branco" started in October, 2007. The main objective were to support teachers and students in the production of printed or online school newspapers.

50 teachers, and 600 students in 24 schools in Castelo Branco region (Portugal) have been involved. Along the school year, several training sessions on Media Education where organized for inservice teachers. Materials were developed and validated, such as the DVD "Let's produce school newspapers", a platform for online newspapers and a handbook to help students and teachers producing the newspapers.
