Jean Monet Network Project *Citizenship Education in the Context of European Values (CitEdEv)*

- Grant proposal successful and awarded in August 2020 but Covid-19 pandemic has seen a project extension from Council of Europe granted. Aims of project are:
 - Foster youth participation in democratic life and active civil society
 - Engage policy makers at inter- and trans-national levels
 - Strengthen meaningful research, cooperation, and networking
- 28 universities across 19 European countries (led by Charles University)







1. Best Book Award

György Csepeli & Antal Örkény *Nation and Migration*

How Citizens in Europe are Coping with Xenophobia



(Central European University Press)

- The book addresses the inseparable relationship between nation and migration and discusses such issues as the social integration of migrants or the dilemma between moral cosmopolitanism and national self-ceteredness
- Experiences relating to migration of 23 European countries are analyzed based on data from the International Social Survey Programme.
- The authors state: the divergent approaches of Eastern and Western Europe to the challenges of nation and migration is one of the European Union's greatest challenges in the twentyfirst century.

Nosek-Kozłowska, K. (2021). The image of **transnational families** in the prism of the experiences of children growing up in them. *Scientific Quarterly Fides et Ratio*, 45(1), 125-136. *The paper discusses an under-researched, however more and more prevalent phenomenon in Europe i.e. children growing up in the so called "transnational families"* (one or both parents work abroad) How to maintain family life and parent-child relationship among these circumstances – from the children's perspective.
